The trucking industry is short 80,000 drivers, a record high reported by Chris Spear, President and CEO of the American Trucking Associations. That's a 30% increase from before the pandemic, when the industry already faced a labor shortage of 61,500 drivers. Many drivers are retiring, dropping out of the industry. Increased consumer demand, prompting a need for more drivers and failed drug and alcohol test also plays a big role in the shortfall. More than 72,000 truck drivers have been taken off US roads since January 2020 because they have failed drug tests that are now required by the Drug & Alcohol Clearinghouse a registry established to increase safety on US highways.
