Company Owner?**

Do you know your DOT requirements to starting a trucking business?

There are so many benefits to running a trucking business. In addition to a valid CDL (commercial driver's license), owner-operators must also fulfill a number of requirements outlined by the FMCSA (Federal Motor Carrier Safety Administration). Any person operating a CMV requiring a CDL in intrastate or interstate commerce is required to participate in a DOT Drug & Alcohol Testing Program. Owner-operators must register with a consortium and participate in the Consortium's random testing pool. The purpose of this is to establish programs designed to help prevent accidents and injuries resulting from the misuse of alcohol or use of controlled substances by drivers of commercial motor vehicles. Many new company owners are not aware of these requirements and get surprised with a huge fine when they are chosen to go through an audit. We can take care of all the extra work for you! We have a great Random program that will keep your company in compliance with the Department of Transportation. We offer Background checks, DOT and Non-Dot Physical, random drug and alcohol testing and if you can't come to test at any of our six locations we will find a collection site near you.
