**Do you know the drug testing process?**

So many questions come to mind when choosing a drug test location. For example: When will I get results? What are the turnaround times? Who gets my result? Why do I need to provide the MRO with additional information? When you have your test performed at Drug Screen Compliance, we have a special courier fly it out the same day to our main lab in Lenexa, Kansas. This allows us to provide you or your employer with results within 24 to 48 hours from the time it arrives at the lab. Some tests can take a few extra days depending if there are any weather delays or abnormalities in your results. Should a drug test come back positive we follow a strict protocol which the MRO receives the result first and has to contact the donor to verify prescriptions. For DOT samples it is Texas State Law to keep the result for 10 days before we can release them if we have made several attempts to contact the donor without success. Non-Dot results get released by the Medical Review Officer within 3 days. Some employers prefer a rapid test in order to avoid the turnaround times and get results within 10 minutes. Keep in mind that rapid tests can NOT replace a DOT test and are not acceptable for some reporting agencies. All results are sent directly to the company who requested the drug test and we cannot provide any information to the donors in regards to their drug test results unless they paid for a self-test.
